Midwest Alliance for Patient Safety PSO Presents Patient Safety Champion Awards to FHN Memorial Hospital and Northwestern Medicine Lake Forest Hospital

Naperville, Ill.— The Midwest Alliance for Patient Safety (MAPS) Patient Safety Organization (PSO) presented two MAPS PSO Patient Safety Champion awards today in recognition of extraordinary efforts to improve patient safety in healthcare.

The individual award went to J. Steve Harweger, AGACNP-BC, a gastroenterology (GI) nurse practitioner at FHN Memorial Hospital in Freeport, Illinois. MAPS, an Illinois Health and Hospital Association (IHA) company, presented staff from Northwestern Medicine Lake Forest Hospital in Lake Forest, Illinois, with the team award. Kelley Messmer, RPh, with OSF Home Care in Peoria, Illinois, received an Honorable Mention.

Harweger was honored for his lifesaving attention to detail when reviewing a patient's medical records. A 69-year-old male patient was experiencing abdominal pain upon arrival at FHN's emergency department, where he underwent testing. During a GI consultation, Harweger discovered new details about the patient's condition and identified a major concern with the patient's electrocardiogram (EKG). This significant clinical finding triggered immediate cardiac intervention and urgent surgery.

"It does not come as a surprise that Steve would receive such an honor," said Meghan Cox, MBA, Director of Physician & Provider Services. "Steve is a thorough, quality-focused clinician who treats patients with respect, empathy and compassion."

For the team award, the MAPS PSO committee honored the following staff members at Northwestern Medicine Lake Forest Hospital:

Working together, the team successfully reduced hospital-associated pressure injuries by 83% from 2019 to 2021. Key tactics included weekly huddles between frontline leaders and clinicians, as well as Leadership Gemba walks—a Lean Six Sigma practice where leaders spend time with frontline employees during the workday.

During the huddles and walks, it became clear that patients at risk of pressure injuries required early intervention for better outcomes. Reviewing data helped the staff identify which interventions were most effective.

"This is where real-time coaching came into play," said Kathryn Thomas, MSN, RN, CPHQ, Director of Quality and Patient Safety for Northwestern Memorial HealthCare's North Region. "Real-time coaching allowed for near real-time defect identifications and subsequently real-time correction."

MAPS awarded an Honorable Mention to Messmer, an OSF Home Care team member. As a clinical home infusion pharmacist, Messmer is diligent about verifying patients' laboratory orders before discharge. In one case, her actions unveiled lab results that, if undetected, could have resulted in irreversible kidney damage.
