

<u>Public Act 99-0767</u> encourages and expands construction opportunities for female-owned, minority- owned, veteran-owned and small business enterprises, while ensuring hospitals have flexibility and clear guidance on any new reporting requirements.

Here are definitions and resources for hospital leaders as they work to comply with the law.

**Disadvantaged Business Enterprises** 

Socially and economically disadvantaged individuals own at least a 51% interest in <u>these for-profit small businesses</u> and control management and daily business operations. African-Americans, Hispanics, Native Americans, Asian-Pacific and Subcontinent Asian Americans, and women are presumed to be socially and economically disadvantaged. Other individuals can also qualify as socially and economically disadvantaged on a case-by-case basis.

## **Business Enterprise Program**

The Illinois Department of Central Management Services <u>Business Enterprise Program</u> (BEP) promotes the economic development of businesses owned by minorities, women and people with disabilities. Businesses do not need to be certified with BEP as a minority-owned business, female-owned business or disabled-person owned business to bid on state contracts. Any qualified business can bid for contracts posted to the Illinois Procurement Bulletin. BEP certification is specifically for diverse businesses to compete as sub-contractors.

You can find registered <u>BEP vendors</u>, <u>small business vendors</u> and veteran-owned small businesses/service-disabled veteranowned small businesses (<u>VOSB/SDVOSB</u>) <u>vendors</u> on the State of Illinois website. Search by vendor, commodity (service) code or commodity name across the state or by region. Other search criteria for the state directories include county, gender, ethnicity and BEP certification code.
